## **Camper and Parent/Guardian Responsible Use Guidelines: Online Summer Camp Program**

Participation in the Online Summer Camp Program imposes certain responsibilities and obligations on campers and their parents/guardians. Campers are expected to behave responsibly while online.

**Campers will** arrive on time and be prepared for Camp; dress appropriately for a positive camp environment; ensure camper backgrounds are appropriate to a positive camp environment; communicate with instructors, counsellors and other campers with respect in all interactions, including video conferences and discussion areas; be active and engaged in the Online Summer Camp Program; follow the instructors' guidelines for the use of video conferencing; consider whether any posting reflects poorly on the camper, other campers or the Camp or Rouge Valley Conservation Centre; not post, publish or display any defamatory, abusive, obscene, threatening, intimidating, racially offensive, homophobic, sexist or otherwise discriminatory material; use resources provided for the Camp for authorized purposes only; and use only legal versions of copyrighted software in compliance with licensing agreements.

**Parents/Guardians will** understand the risks associated with the Camp they have registered the camper in and ensure adequate supervision is provided, including, but not limited to: ensuring internet safety for the camper; providing adequate supervision when materials, tools and equipment are required in the course of the Camp; ensuring that physical activities are done in a safe and appropriate environment; where a supplies and materials list is posted, ensuring that campers have all of the supplies required for successful participation in the Camp; ensure that resources provided for the Camp are used for authorized purposes by the intended user only; review, understand and accept the terms and conditions, including privacy policies, of any video conferencing and third party platforms used in the course of the Camp; and contact the Camp if they have any concerns at 416-282-8265 or [education@rvcc.ca](mailto:education@rvcc.ca).

## **Interact with other Campers and Staff Appropriately**

Campers will not record or take a picture of anyone on video conferencing without written consent of that person or persons; alert Camp staff if they see other campers being threatened, intimidated or bullied online; be transparent and authentic. Campers will not create a false identity or impersonate any person or organization for any reason, or encourage others to do so; avoid impulsive, inappropriate or heated comments; respect the privacy and confidentiality of personal information regarding other members of the Camp community.

## **Use of Video Conferencing**

As part of the Online Summer Camp Program, the Camp may require the use of video conferencing services (the "Video Service"). The Video Service is to be used for internal and educational uses only.

Please note that instructors may record classes to provide recordings of virtual lessons, which will be maintained in a virtual Camp library. The purpose of recording and providing these virtual lessons is to permit access to those campers who were not able to participate in a lesson due to extenuating circumstances or to reinforce concepts that were taught. Recordings may be retained by the Rouge Valley Conservation Centre to be used solely for internal and educational purposes only.

## ROUGE VALLEY FOUNDATION WAIVER OF CLAIMS AND IDEMUNITY Rouge Valley Conservation Centre Summer Day Camp
